



Distribution Partners of quitt with Commission Model: Version November 2023

Subject	<p>The distribution partner wants to mediate the current services of quitt (see www.quitt.ch).</p> <p>To identify the referral, quitt generates an individual voucher code for the distribution partner. The distribution partner then provides this voucher code to their customer. New quitt customers enter this code at the end of the registration on www.quitt.ch in the «Voucher code» field.</p>
Commission & voucher code	<p>For each referral leading to a paid contract conclusion, a one-time commission is paid to the contractual partner. Contractual partners have the option to split this commission amount between themselves and their customer. The customer receives a credit towards the quitt service fees for the corresponding amount.</p> <p>For the «Comfort» and «Flat» tariffs, the customer credit is directly offset against the quitt service fee. For the «Start» tariff, the customer credit is offset against the quitt commission in the first payroll processing.</p> <p>The payout of the commission to the distribution partner occurs once the customer has processed a cumulative gross salary of 1000 CHF through quitt. The payout is made annually in February of the following year.</p> <p>For the referral of a new customer, ServiceHunter AG pays the following one-time commissions:</p> <ul style="list-style-type: none">• quitt tariff «Start»: 40 CHF• quitt tariff «Comfort»: 80 CHF• quitt tariff «Flat»: 160 CHF <p>There is no commission or customer credit for the conclusion of additional insurance policies (sick pay insurance, household insurance, and employer defense insurance).</p> <p>The voucher code can only be used by new customers and cannot be combined with other discounts.</p>
Expenses	<p>The expenses and costs of the distribution partner are covered by the commission or discount and are not separately reimbursed.</p>

**Contract duration**

This contract automatically becomes effective when the corresponding checkbox is selected during the digital registration of a new partner.

The contract can be terminated by either party with a one-month notice, effective at the end of a calendar month. The termination must be in writing.

For voucher codes redeemed by the customer before the end of the contract, commission is due according to the above provisions. No commission is due for voucher codes redeemed by the customer after the end of the contract.

Changes

Changes and additions to this contract, especially the agreement of different remuneration, require written form.

Confidentiality

The parties agree to treat the content of this contract and the transactions described therein as confidential. The distribution partner may only communicate voucher codes and associated customer credits to potential customers.

Severability clause

If any provision of this contract is or becomes invalid in whole or in part, the remaining provisions remain unaffected. Any resulting legal vacuum shall be replaced by an agreement that corresponds to the parties' intention.

Applicable law and jurisdiction

Swiss law applies to this contract.

The exclusive place of jurisdiction for disputes arising from or in connection with this contract is Zurich.

This contract has been enacted in German with an English translation thereof. In case of controversy, the German text prevails.
